RE: 3rd Quarter 2010 Results – SunTrust Bank

I am pleased to share the 3rd Quarter 2010 crime incident results for the senior housing facilities sponsofed through the Senior Housing Crime Prevention Foundation. The first graph is for the senior housing facility you support through the Foundation. SunTrust Bank's participation has resulted in a crime reduction rate of 73.33% for the period ending September 30, 2010. The second graph reflects an incident reduction rate of 95.23% throughout the Veterans nursing homes your bank sponsors through the Foundation's Veterans Initiative.

Nationally, there has been an overall crime reduction rate of 92.59% for the same time period. On behalf of the Veterans, residents and family members – thank you!


Thank you for your continued support of the Foundation and the difference SunTrust Bank is making in your community with the Senior Crimestoppers program.

As of September 30, 2010




